AltTox Forums Update

In response to advice from members of the AltTox community, the AltTox Management Team has arranged for the following disclaimer to appear automatically at the end of all messages posted to the forums:

The views expressed in the AltTox forums are those of the individuals posting them and not necessarily those of their home institution.

Some AltTox members felt that such a disclaimer was necessary to indicate that statements posted by forum participants should not necessarily be construed as representing the views or policies of their home institution - whether a corporation, regulatory agency, or any other entity. The Management Team hopes that the new disclaimer adequately addresses this concern and that the change will encourage more open discussion of issues. Currently, the forum postings are largely informational in nature and generate little feedback. While these are perfectly appropriate for the forums, the Management Team also encourages the posting of views and perspectives that generate commentary from other members of the AltTox community.
