US EPA Sets Priority List for Endocrine Disruptor Screening Program

The US Environmental Protection Agency (EPA) recently announced the final list of the first group of chemicals to be tested in Tier 1 screening under the Endocrine Disruptor Screen Program (EDSP). This list consists of 67 chemicals that are pesticide active ingredients and pesticide inert ingredients considered to be high production volume chemicals. The Agency used exposure potential as the primary factor in determining what compounds to put on the list.

This phase of the EDSP will undoubtedly entail considerable use of animals. EPA is required to "develop a screening program, using appropriate validated test systems and other scientifically relevant information" to determine whether "pesticide chemicals" may "have an effect in humans that is similar to an effect produced by a naturally occurring estrogen" under the Federal Food, Drug, and Cosmetic Act.¹ EPA is concurrently validating the whole battery of screening assays to be used in Tier 1 testing. The status of these can be viewed [here](#). The majority of tests are animal based. However, the Washington Post reported that in an April 3 letter to CropLife America, EPA stated the agency is "leaving open the possibility of sometimes using computer modeling rather than relying exclusively on laboratory animal testing...and would be willing to lower the number of lab animals required for testing."²
